- 8:00AM – Vendor gates open
- 10:30AM – Set up must be complete and non-service vehicles removed from site.
- 11:00AM – Public gates open
- 10:00PM – Public gates close
- 11:00PM – Teardown must be complete.

Nothing is to remain in the park. Please remove all garbage and waste.

INFORMATION AND GUIDELINES

In Consideration of being granted space as a food vendor by the Roots and Fruits Expo, the vendor agrees to the following terms, conditions, and considerations:

POWER SUPPLY/ACCESS:

- **Vendors must disclose their maximum power requirements necessary to run from the start of the event to finish on this application.** We have limited power supply including standard 110v plugs and 2 stations that can provide a maximum draw of 30amps. We cannot provide 50amp service to vendors. Approval and placement will depend on the vendor's power requirements. Vendors who booked a power site are responsible for ensuring that all their equipment, power cords, and plug-ins meet BC safety Authority Electrical Standards. All vendors will be inspected by the Festival electrician prior to opening for service and operation will not be permitted if vendor is in violation or is using damaged electrical cords.
- Vendors must provide their own water source for service and dispose of greywater at an approved sani-dump.
- Town of Oliver makes efforts to be environmentally conscious and minimize the carbon-footprint of our events. **No Styrofoam** containers may be used, please choose the most environmentally friendly containers and flatware possible. Please provide a garbage can at your station, garbage can be added to the event dumpsters.
- Vendors are responsible for any damage to their site. Vendors should take measures upon leaving to ensure that their location does not have any grey water, grease, debris, or garbage. We will keep your \$25 damage deposit if we determine your site to need extra attention after the festival.
- The festival site is **non-smoking**, except in designated areas and **no pets** are allowed at the venue.
- Vendors must be open by 11:00 AM on June 23, and remain open until gates close to the public. See application for specific timeline.
- The Town of Oliver, contractors, employees, and volunteers shall not be held responsible in any way for any physical or personal damage, loss of goods or property, or liability associated with this event.
- The Vendor expressly agrees to adhere to all Municipal, Provincial, and Federal statuses, bylaws, and regulations in obtaining proper permits and licenses to operate their business.
- The Vendor is not permitted to sell or serve any alcoholic beverages and to ensure that their employees and representatives are not under the influence while serving.
- Vendors who are in violation of the guidelines, are abusive to staff, volunteers or guests; or who display disorderly conduct may be forced to close and be removed from the Festival until they are able to return for tear down.
